### 6 April 2018:

- Deferred Debt Arrangements (Reg 6F Employer Debt Regs SI 2005/678)
- (De)-registration of schemes with a dormant sponsoring employer (Finance Act 2018 Sch.3)

### 10 May 2018:

· Single Finance Guidance Body in Autumn 2018 (Financial Guidance and Claims Act 2018)

#### 1 October 2018:

- Regulation of master trusts (Pension Schemes Act 2017 and Occupational Pension Schemes (Master Trusts) Regulators 2018)
- Limiting statutory right to transfer out (timing tbc); ban on cold calling (timing tbc)

#### 2019 / 19 March 2018:

· Retrospective "White Paper Legislation"?

- BEIS: Nuclear Decommissioning Authority: Pensions Reform Consultation
- The "Frank Field effect" ie impact on commercial activity (eg Bhs, British Steel, Toys-R-Us, Arcadia, Palmer & Harvey, Carillion, Royal Mail, Anglian Water and United Utilities, Melrose/GKN, Asda/Sainsbury ....)
