# Requirements by category

#### Category 1:

### **Practising Certificate Holders**

- At least 30 hours of CPD
- 20 hours must relate to technical learning
- 10 of the technical hours should be gained at external events
- 2 hours of Stage 3 Professional Skills Training (PST) (NB PST counts towards your overall CPD requirement)
- Must record a learning outcome for each CPD activity listed in your online CPD record.

#### Category 2:

### Fully Regulated Fellows an Associates

- At least 15 hours of CPD
- 5 hours must be obtained at external events
- Stage 2 or 3 of the PST, as relevant (NB PST counts towards your overall CPD requirement).

#### Category 3:

# Partially Regulated Fellows and Associates

- Must comply with the CPD requirements of your primary regulator
- Must also complete either Stage 2 or 3 of the PST, as relevant.

#### Category 4:

#### Certified Actuarial Analyst

- At least 15 hours of CPD
- 5 hours must be obtained at external events
- 2 hours must contribute to your understanding of ethical behaviours in relation to your role.

# Category 5:

#### Student Member

- No technical skills requirement
- Must complete Stage 1, 2 or 3 of the PST, as relevant.

#### Category 6:

#### **Student Actuarial Analyst**

- No technical skills requirement
- Must complete stage 1 PST by the end of your first CPD year.

## Category 7:

#### Retired Member

- If you meet the requirements for this category, you can apply to be classified as retired
- No CPD requirements unless undertake unpaid work which relies on your actuarial training and experience, in the widest interpretation.

#### Category 8:

#### Honorary Fellows and Affiliates

No CPD requirements.
