Reporting to the Education Board

1. OVERARCHING AIMS:

To be responsible to the Education Board for maintaining a modern and effective system of educating potential actuaries and certified actuarial analysts so as to ensure that the supply of qualified actuaries and certified actuarial analysts continues to be of high standard

2. KEY RESPONSIBILITIES:

- To liaise with the Board of Examiners and make recommendations to the Education Board for any changes to the assessments to ensure that, whilst maintaining high standards, the assessments are a fair test for candidates, for both examinations leading to Fellowship, Associateship and the Certified Actuarial Analyst qualification
- To be responsible for maintaining the Institute and Faculty of Actuaries accreditation for CERA on behalf of the IFoA Council.
- To review the implementation of the Education Strategy.
- To ensure that up-to-date Core Reading material is prepared.
- To be responsible for the work of the Syllabus and Core Reading Review Groups and regularly review and recommend changes to the syllabus.
- To recommend to the Education Board and Council standards for admission as students.
- To award and oversee exemption recognition agreements and accreditation agreements.
