#### ACCIDENTS.

Provisional Statement of the Number of Deaths by Accidents at Mines and Quarries in Great Britain, together with the Isle of Man, during 1948. (2d.) Ministry of Fuel and Power Statistical Digest, 1946 and 1947. Cmd. 7548. (3s.)

Includes statistics of persons killed and injured in coal mines, analysed by age, cause, etc.

Annual Report of the Chief Inspector of Factories for the year 1947. Cmd. 7641. (2s. 6d.)

Gives statistics of fatal and non-fatal accidents analysed by cause, industry, etc., and of industrial diseases.

### ARMED FORCES.

Statistical Report on the Health of the Army, 1943-45. (20s.)

Deals with wastage and morbidity by causes, the relation of age to wastage, surgical casualties, etc.

Examines the principles which should govern the selection of diseases for insurance under the National Insurance (Industrial Injuries) Act, 1946.

#### INFANT MORTALITY.

Reports on Public Health and Medical Subjects, No. 94. Neonatal Mortality and Morbidity. (15. 6d.)

A discussion of the causes of neonatal mortality and morbidity and of preventive measures, with miscellaneous statistics.

## MAN-POWER,

Includes statistics of population, births, deaths and marriages, the principal statistics relating to labour and production and financial statistics for the United Kingdom.

Monthly Digest of Statistics. Supplement. Definitions and Explanatory Notes. Revised March, 1949. (6d.)

Annual Abstract of Statistics, No. 85. 1937-47. (10s.)

Contains a wide range of social and economic statistics relating to the United Kingdom. Current data for many of the series are contained in the *Monthly Digest of Statistics*.

## POOR RELIEF.

Return showing the number of persons in receipt of Poor Relief in England and Wales on the night of 1 January 1948. H.C. 8/1948. (9d.)

An analysis of the numbers of men, women and children in receipt of relief according to type of relief, physical and mental condition, domestic circumstances, etc., with local particulars for each administrative county and county borough.

#### PUBLIC HEALTH.

Report of the Department of Health for Scotland for the year 1948. Cmd. 7659. (1s. 6d.)

A survey of public health in Scotland and an account of the work of the Department in various fields, with statistical appendices.

General Register Office. Studies on Medical and Population Subjects. No. 2. Sickness in the population of England and Wales in 1944-47. (1s.)

Examines the value and limitations as indices of morbidity, of information derived from notifications of infectious diseases, from the sample Sickness Survey carried out monthly since 1943 and from statistics of special food allowances.

## STATUTES, ETC.

Public General Acts, 12 & 13 Geo. 6:

Ch. 23. Social Services (Northern Ireland Agreement) Act, 1949. (2d.)

Gives effect to an agreement, made between the Treasury and the Ministry of Finance for Northern Ireland, with a view to assimilating the burdens on the Exchequer of the United Kingdom and the Exchequer of Northern Ireland in respect of certain social and allied services.

A Bill to authorize a contributory pension scheme for the widows and children and for certain dependent relatives of established civil servants and to provide for certain other changes in the existing law on Civil Service superannuation.

### UNEMPLOYMENT INSURANCE.

Unemployment Fund Investment Account, showing the nature and amount of the Securities held by the National Debt Commissioners at 4 July 1948 as Investments for Moneys, forming part of the Unemployment Fund, paid over to them by the Ministry of National Insurance. H.C. 52/1948-49. (1d.)

#### VITAL STATISTICS.

The Registrar-General's Statistical Review of England and Wales:

Tables. Part I. Medical: for 1946. (6s.)

Contains statistics of deaths and death-rates by sex, cause, age and locality. Comparative mortality indexes based on the year 1938 are given for each sex and for certain causes of death. The numbers of deaths at each age are shown by sex and marital condition.

Tables. Part II. Civil: for 1946. (2s. 6d.)

Contains statistics of population, births, deaths and marriages by administrative areas, analyses of marriages by age and civil condition, and tables relating to the fertility of women.

The Registrar-General's Estimates of the Population of England and Wales, Civilian populations of each administrative area at 30 June and 31 December 1048. (4d.)

Ninety-Second Annual Report of the Registrar-General for Scotland, 1946. (5s. 6d.)

Gives statistics of population, births, marriages, deaths, infant mortality, etc., with summaries for administrative areas. Deaths at each age are shown by sex and marital conditions. Tables relating to the fertility of women are also included.
