Assurance Companies Acts, 1909–1946. Summary of Statements of Assurance Business deposited with the Board of Trade during the year ended 31 December 1955. (7s. 6d.)

The summaries cover new ordinary life assurances effected during 1954, ordinary life assurances and annuities in force at the last valuation, revenue accounts for each type of business, profit and loss accounts, balance sheets, for each company, with totals for previous years; etc.

CENSUS OF POPULATION

Census 1951, Scotland. Volume IV. Occupations and Industries (with some particulars of (a) the extent to which people live in one area but work in another, and (b) occupations in relation to school-leaving age). (1205.)

Occupations are analysed by sex, age, conjugal condition, industrial status, area, etc., and industries by sex, industrial status, area; the principal industry groups are analysed by functional and status divisions, sex, age, principal occupations.

MORBIDITY STATISTICS

Studies on medical and population subjects, No. 9. General Practitioners' Records. An analysis of the clinical records of some general practices during the period April 1952 to March 1954. (6s. 6d.)

Gives results from the latter part of an enquiry designed to determine the extent to which general practitioners' records could be used as a source of general morbidity statistics. A full explanation of the enquiry and preliminary results were given in Study No. 7, referred to in *J.I.A.* 80, 123.
