The Committee was appointed to consider how far proceedings for the recovery of damages or compensation in respect of injury caused by negligence should affect or be affected by the provision under Workmen's Compensation legislation or under any social insurance scheme, and whether any alteration was desirable in the law governing the liability of employers or third parties to pay damages independently of the Workmen's Compensation Acts, and to consider the question of the recovery of the cost of reconditioning and vocational training.

Authorizes further increases and otherwise amends the Acts of 1920 and 1944 relating to pensions payable in respect of public service.

Ch. 27. National Health Service (Scotland) Act, 1947. (1s. 6d.)

Corresponds with the legislation for England and Wales, noted above.

### VITAL STATISTICS.

The Registrar-General's Statistical Review of England and Wales:

Tables. Part I. Medical: for 1942. (5s.)

Contains statistics of deaths and death-rates by sex, cause, age and locality with comparative statistics for earlier years. Comparative mortality indexes based on the year 1938 are given for each sex and for certain causes of death. The numbers of deaths are shown at each year of age by sex and marital condition.

Tables. Part II. Civil: for 1942. (1s. 6d.)

Contains statistics of population, births, deaths and marriages by administrative areas, further analyses of marriages by age and civil condition, and tables relating to the fertility of women.

Text: for 1938 and 1939. (4s. 6d.)

A study of vital statistics for the years under review, with special reference to the trend of mortality from the main causes. Included in the new material in this volume is a commentary on the data regarding fertility obtained as a result of the provisions of the Population Statistics Act which came into operation in July 1938.

The Registrar-General's Decennial Supplement, England and Wales, 1931. Part IV. Multiple or Secondary causes of death. (12s. 6d.)

Provides statistics, based on samples of the deaths in 1921 to 1930, of the frequency with which two or more causes occur in association, and of the total frequency of occurrence of each separate cause, either as a primary cause or as a subsidiary or secondary cause.

Ninetieth Annual Report of the Registrar-General for Scotland, 1944. (4s. 6d.)

Contains statistics of births, marriages, deaths, infant mortality, etc., with summaries for administrative areas. Deaths at each age are shown by sex and marital condition.
