

Call for Speakers

To All Institutions Concerned,

We are writing this letter for recruiting for speakers.

For this, in order to enhance the education and training quality, integrate and share the related resources efficiently, enrich the lecturer team and provide better intellectual support for human resources development of the insurance asset management industry, the IAMAC is currently seeking professional speakers. Professionals from related institutions are welcomed to apply and qualified candidates would be employed by the IAMAC. Specific issues are as follows:

I. Obligations and Requirements:

In this role, you shall:

1. Coordinate with the association to deliver and record lectures.
2. Share expertise and career experience.
3. Comply with confidentiality agreements of the Association.
4. Research on the education and training of the industry, actively participate in curriculum development and provide advices.

To be successful in the role, you should meet the following requirements:

1. Abide laws and disciplines, maintain probity and self-discipline and keep honest and trustworthy, with good professional ethics, solid theoretical foundation and excellent presentation skills.
2. Achieve bachelor degree or above.
3. Work in finance, insurance, law, management, human resources and other related fields for at least three years, with outstanding professional competence, remarkable achievements and innovation ability, or play a leading role in the related industries, with a good reputation and significant influence.
4. Have project achievements or promotion experience in the relevant fields. Those with overseas working experience are preferred.
5. Accept the management of the Association and comply with the self-discipline rules and other requirements.

The IAMAC would provide the lecturers with:

1. A platform for industrial exchange and sharing.
2. A package of training.
3. A privilege to participate the study and training of the professional fields.
4. An opportunity to enhance the professional influence.
5. An appropriate reward depending on circumstances.

II. Topics and Contents

Topics and contents include:

1. Investment: including asset allocation, equity investment (stock, security investment fund), quantitative investment, fixed income investment (bond, privately raised bond, perpetual security, etc.), infrastructure and real estate investment, stock right investment reserves, overseas investment and financing, private equity fund, mergers and acquisitions mezzanine fund, asset securitization, Public-Private-Partnership (PPP), “the Belt and Road” investment, new OTC market investment, real estate investment trust (REITS), financial derivatives, financial leasing, non-performing assets securitization(NPAS), etc.
2. Risk Management: including risk management tool, method and system, credit rating, credit risk control, interest risk management, and exchange rate risk management, etc.
3. Operating Guarantee: including issuance asset custody, valuation and accounting, and operation management, etc.
4. Operation Management: including human resources management, IT operation, and internet

finance, financial management, etc.

5. Other fields: including pension and annuity management, old-age support, health and medical issues, Fintech, Blockchain and Internet Plus etc.

III. Application and Recruitment Procedures

Application and recruitment procedures go through the following:

1. Applicant should complete the application form (refer to the enclosure) and send it to inter_affairs@iamac.org.cn
2. We will reply via email after receiving the application. Please contact us if not getting our feedback. (See contact information below)
3. Organizing Committee would be set by the Association to conduct the preliminary screening, considering the expertise and experience of the applicant and the business operations of his or her employer.
4. After the preliminary screening, an interview (i.e. a trial lecture,) might be arranged by the Committee to evaluate the qualification of each potential lecturer and reach the final result.
5. The selected would be awarded the letter of appointment. Appointment system would be applied for speaker and the lecturer pool would be managed dynamically.
