"Task" Specification

The key tasks of the sub-committee are:

- guide and advise the IFoA as to the strategic direction of IFoA research publications. This includes, but is not limited to:
 - British Actuarial Journal (BAJ)
 - Annals of Actuarial Science (AAS)
 - Longevity Bulletin
 - Sessional Research Papers
 - Research papers formally published from IFoA-sponsored research
 - o Symposium papers and other formal conference research publications
 - International Series on Actuarial Science books, published by Cambridge University Press
- maintain a holistic view of the IFoA research publication programme to identify links, themes, overlaps and opportunities
- ensure research publication plans are aligned to the IFoA's strategy and corporate plan, and the delivery models are fit for purpose
- ensure the content of IFoA research publications is relevant to the actuarial community and related disciplines
- advise on choice of any external publishers, for example for the BAJ and AAS
- identify policy issues and how these can be integrated into the planning and implementation of the publication of research publications
- outside the IFoA journals, ensure appropriate quality assurance is in place for the publications under the sub-committee's review and act as arbitrator, when issues are escalated.

The role

The RTLC Publications Sub-committee is seeking a new member. The committee member will be required to:

- ensure IFoA mortality, morbidity and longevity research aligns with the IFoA strategic objectives
- maintain awareness of current research, emerging issues and hot topics in mortality, morbidity and longevity research and communicate these to the committee members
- · review and quality assure research outputs when required
- identify appropriate dissemination channels for IFoA mortality, morbidity and longevity research including, engagement with diverse stakeholder groups
- promote the IFoA's thought leadership and knowledge exchange activities to relevant stakeholder groups
- attend two RTLC Publications Sub-Committee meetings each year in person or by conference call.

Reporting

You will report in to the Chair of the RTLC Publications Sub-Committee.

Tenure

This is a three year appointment.

Time Commitment

Two meetings are held each year in Exchange Crescent, Edinburgh. Members can attend in person or by conference call. Meetings last no longer than two and a half hours. Time is also required to read through committee meeting papers.

"Person" Specification

He or she will require to be someone who:

- is a Fellow, Honorary Fellow, Associate, Affiliate member of the IFoA or established academic in the field of actuarial science or a related discipline. Non members who have relevant expert and subject knowledge and a background and expertise in Group Business may also apply
- has an awareness of current research themes and topics in the wider actuarial field and/or related disciplines.
- has experience of reviewing research outputs such as conference papers and research reports.

In addition, a background in commercial or academic research would be advantageous

In return, the volunteer will:

- be provided with excellent professional support and assistance during your tenure on the committee
- develop an effective network of contacts across the industry
