# CMI Management Committee – Terms of Reference

These terms of reference were adopted by a resolution of the board of directors of Continuous Mortality Investigation Limited (“CMI”) passed on 2 July 2019.

## Purpose

Manages the operations of CMI to achieve the strategic aims set by the CMI Executive Committee

## Key Responsibilities

### 1. Governance

- a. Acts within these Terms of Reference and CMI's Internal Governance Procedures.
- b. Recommends to the Executive Committee changes in the Terms of Reference of the investigation committees.

### 2. Oversight and reporting

- a. Oversees the running of CMI and its committees in accordance with the annual objectives, timescales and budgets set by the Executive Committee and reports on progress quarterly.
- b. Monitors the financial position of CMI and alerts the Executive Committee of any deviances or expected deviances in income or expenditure in accordance with the Internal Governance Procedures.:
- c. Ensures that the plans and budgets of CMI's committees submitted to the Executive Committee each year are consistent.
- d. Oversees the operations and effectiveness of the Secretariat.
- e. Oversees the operation of the quality assurance standards set by the Executive Committee.
- f. Monitors risks that may threaten the achievement of operational objectives and how these are managed and reports quarterly to the Executive Committee on its assessment of these risks.
- g. Oversees the operation of the data security policy set by the Executive Committee.

### 3. Other responsibilities

- a. Encourages data submissions to CMI.
- b. Manages the timing of release of potentially sensitive information.
- c. Ensures that CMI undertakes comprehensive and effective promotional activity.
- d. Recommends setting up working parties or task forces, to deal with any new areas of activity or special projects that sit outside the remit of the investigation committees, to the Executive Committee.
- e. Considers requests for provision of data for research to universities and other establishments.
